The Foundation contracted a new company to secure Plans and Land Use Permits. The company completed, submitted and received City approval for the site plan. An existing well was demolished in accordance with local and state laws and storm water and erosion plans were submitted for review. Public comments were solicited, submitted to the city and approved. The Foundation entered a 30 year covenant with the City restricting the land use to low income housing. Final applications for land use permits were submitted for approval, which is expected in early 2025.
